To Our Patients:

As part of your visit to the John Wayne Cancer Clinics at Providence Saint John’s Health Center you can expect to receive bills from both the facility and the physician. If you require additional services such as a MRI or a review of your pathology slides, additional fees for these professional services will be billed separately. All price quoted by SJHC are for Hospital facility charges only. Depending on the services that you were provided, you may also receive bills for professional services rendered by hospital contracted Radiologists, Pathologists, Anesthesiologists or others. These providers may or may not be contracted with your insurance carrier(s).

If you are a Medicare participant, your Medicare Part B benefits will be billed for services received during your visit.

Please note that aside from co-pays, other charges may apply depending on your insurance coverage.
